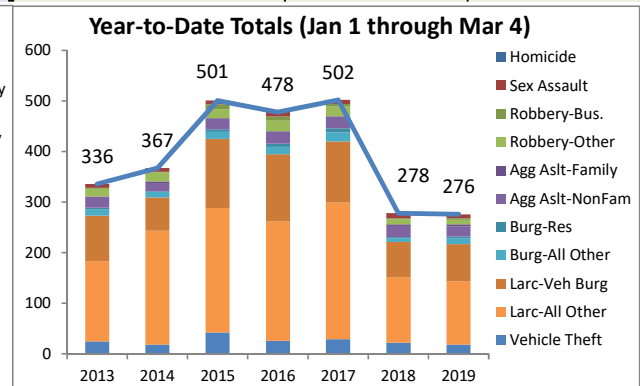
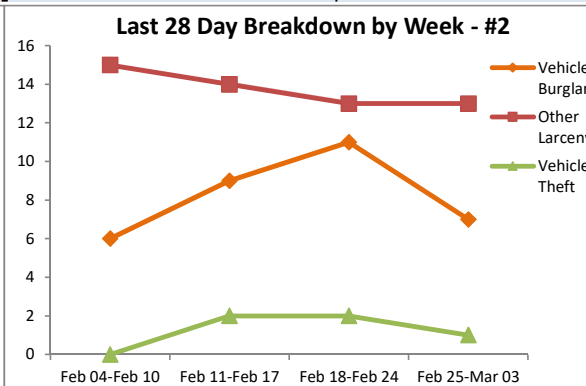
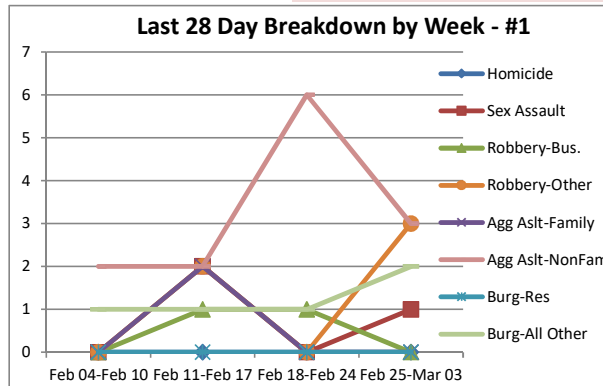

***The Rio Grande District is defined as the area from North Temple to 700 South and State Street to I-15.
